- further liability under the contract of carriage agreed with the customers, within the framework of the stipulated statutory liability range in accordance with Sec. 449, Sub-Sec. 2, Clause 1 HGB with respect to up to 40 special drawing rights per kilogram of the gross shipment weight.

Indemnity is limited to EUR 2.500.000 per insured claim and to EUR 3.000.000 per insured loss event. For ordered warehousing the maximum indemnity is EUR 1.000.000 per aggrieved party and per contract for transport/forwarding.

The insurer/insurers does/do not assume any obligation to third parties on the basis of this certificate. In particular, this certificate shall not oblige the insurer/insurers or OSKAR SCHUNCK GmbH & Co. KG to supply information on modifications to or the termination of this insurance cover.
